Two constructive meetings of the new group have been held in 2024.</li> <li>Two webinars held (with SAI Ukraine and with SAI Somalia) and two more at a planning stage.  Key next steps / action items:</li> <li>Investigate how current material is used and find ways of increasing its usefulness.</li> <li>Explore the ACCC concept – what do we "mean", what describes circumstances for SAIs operating in such contexts.</li> <li>Engage with INTOSAI regions and other INTOSAI bodies.</li> <li>Continue to plan and organize ACCC webinars.</li> <li>Key risk(s):</li> <li>SAIs in complex and challenging contexts struggle to participate/contribute due to limited resources.  Mitigating action: (a) Keep group engaged by regular meetings and identify areas and tasks taking the work forward. (b) Demonstrate the relevance/usefulness of the work.</li> <li>SAIs in complex and challenging contexts unable to make use of material developed.  Mitigating action: (a) Technical and resource limitations taken into consideration and continuously tested and adjusted to circumstances.
